Any incentive claims must be returned to Jo-Carroll Energy no later than 3 months after purchase and **no later than January 3, 2019** and include proper documentation as noted in red below. **\*\*\*All incentives will be issued in the form of a bill credit.\*\*\*** No incentive will be issued if the member has failed to complete all requirements. Jo-Carroll Energy reserves the right to inspect and verify equipment and installation. Jo-Carroll Energy reserves the right to modify or end any incentive program at any time without prior notice.

Please allow 3-5 weeks for your incentive to be processed once proper documentation has been received. **The amount of the incentive(s) given will not exceed 50% of the cost of equipment and installation.** All accounts are eligible for only **one** incentive per appliance/unit within a 5-year time period.
